- 1. - 14. **Caution for Submission of Certificates/Undertakings and Documents**: All certificates and und ertakings required as part of the bid must be presented on the standard letterhead of the OEM or Bidder, a s applicable. Each document must include the following:
  - a. The <u>Bid Number</u> to which the document pertains.
  - b. The <u>Date of Signing</u> of the document, which should be after the date of publication of the bid wher ever applicable. In such cases, documents with older dates may not be accepted in the bid.
  - c. Clear identification of the Document Signatory, including their <u>Name</u>, <u>Designation</u> within the comp any, a Valid Official <u>Email</u>, and a <u>Mobile Number where possible</u>.
  - d. The Company <u>Stamp</u> of the <u>Bidder's</u> company, OEM, or their authorized representative.
  - e. Failure to comply with these requirements may result in the rejection of the bid.
  - f. MCEME may ask original documents of uploaded scanned copies or get them verified from OEM/au thorities. If any substantive discrepancy found between original and scanned uploaded copies; then the bid shall be liable to be rejected as non-responsive and MCEME may enforce Bid Security declaration
- 15. **Option Clause**. The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
- 16. **Repeat Order Clause**. This contract will have a Repeat Order Clause wherein the buyer can orde r up to 50% of the total contracted quantity of product/services under the present contract within six mont hs from the date of successful completion of this contract, the rates, terms and conditions remaining the s ame. While exercising this clause, the overall ceiling of 50% of the total originally contracted quantity will not be exceeded. It will be entirely the discretion of the buyer to exercise this option.
- 17. Fall clause. The following Fall clause is applicable:
  - a. The price charged by the Seller for the services for / in / from / to a particular Station under the contract shall in no event exceed the lowest prices at which the Seller sells the services or offers to sell services of identical description to any persons/Organization including the purchaser or any department of the Central or State Government or any statutory undertaking of the Central or State Government as the case may be, during the currency of the contract.
  - b. If at any time, during the said period the Seller sells or offers the services to any persons/ Organiz ation as mentioned above, at a price lower than the price chargeable under this contract, then he shall notify such reduction or sale or offer of sale to the Buyer immediately and the price payable under this contract for such services shall stand correspondingly reduced.

- 18. **Conflict Clause**. In case of a conflict between the relevant clauses of General Terms & Conditions of GeM, the concerned clause in this document (buyer added Additional Terms & Conditions) will supersede a ll other clauses
- 19. **Termination of contract**: MCEME reserves the right to terminate the contract in whole or in part if the bidder fails to meet its obligations under the contract or breaches any of the terms and conditions ther ein. Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if
  - a. The Seller fails to comply with any material term of the Contract.
  - b. The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stip ulated Delivery Period or such inability otherwise becomes apparent.
  - c. The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period a nd/or to replace/rectify any rejected or defective Material(s) promptly.
  - d. The delivery of the material is delayed for causes not attributable to Force Majeure after the sched uled date of delivery with extension thereto if any.
  - e. The Seller becomes bankrupt or goes into liquidation.
  - f. The Seller makes a general assignment for the benefit of creditors.
  - g. A receiver is appointed for any substantial property owned by the Seller.
  - h. The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
- 20. Only new and unused product/items will be considered for procurement. The specifications provided should meet or exceed the minimum requirements outlined by MCEME. Any defects discovered within the warranty period should be rectified or the product replaced promptly by the bidder at no additional cost to MCEME.
- 21. Acceptance of the Product will be subject to thorough inspection by MCEME, and only products meeting the specified requirements will be accepted.
- 22. The bidder must ensure the confidentiality and security of any data stored or processed on the Product supplied. Any sensitive information provided by MCEME should be handled with utmost care and only used for the purpose of fulfilling the procurement contract.
- 23. Since the Product to be used in defence are not commonly utilised over public internet, it must be en sured that <u>Products have not been connected to the internet</u> before delivery to buyer's organisation.
- 24. **Modification and Customization**: Any modifications or customizations to the Product requested by MCEME must be agreed upon in writing and may incur additional charges.
- 25. **Integrity of Documentation and Ethical Conduct** Bidders are obligated to ensure the authentici ty and accuracy of all submitted documents. Any bid found with counterfeit documents, unauthorized use of brand credentials, or invalid details will be rejected. The buyer may report such unethical conduct to ale rt and protect other buyers within the organization. Bidders must adhere to ethical business practices, and any violation may lead to rejection of the bid and potential legal action.
- 26. Bidder shall submit details such as Make and Model of equipment/item offered for each line and provide datasheet/technical literature in support of technical specifications/functional requirement.
- 27. **Franking Clause**: The following franking clause will form of the part of the Purchase Order placed on Successful Bidders:
  - a. In case of Acceptance of Store(s): The fact that the goods have been inspected after the delivery p eriod and passed by the Inspecting Officer will not have the effect of keeping the contract alive. The g oods are being passed without prejudice to the rights of the buyer under the terms and conditions of t he Contract.
  - b. In Case of Rejection of Store(s): The fact that the goods have been inspected after the delivery pe riod and rejected by the Inspecting Office will not bind the Buyer in any manner. The goods are being rejected without prejudice to the right of the Buyer under the terms and conditions of the Contract.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
